I see what you're saying. I think that would work if the provisions in the bill all related to veterans, but none of the AB 828 provisions pertain to veterans, do they? It's all DOT and DNR stuff... That's why in Act 113 they also added in language such as:

#### 632.64 Certification of disability.

... and to a certification of disability signed by a podiatrist with respect to matters within the scope of the podiatrist's professional license.

It's also why the authors of the bills and chairs of the relevant committees requested that the Department secretaries update their forms to reflect that those signing were doing so under their scope of practice. You can see the reply from DOT attached...

The drafter indicated that definitions are already in statute per 2009 Act 113 (that you had sent to us too). Section 8 of that Act created 45.40(1g)(a) and (b), specifically with (b) saying "... diagnosed by a health care provider acting within the scope of the health care provider's license."

She is thinking because that is already in statutes, it doesn't need repeating. However, I asked her to verify that with colleagues and give me a call back.

I was asking – if you agree that since that definition is already in 45.04... that it does not need repeating in AB 828.
