

- **1.** Page 3, line 15: delete lines 15 to 20 and substitute:
 - "Section 3m. 23.33 (5) (am) of the statutes is created to read:
- 23.33 (5) (am) Roadway restrictions. 1. In addition to the restrictions under par. (a) 1., no person under 12 years of age may operate an all-terrain vehicle on a roadway under any circumstances.
- 2. No person under 16 years of age may operate an all-terrain vehicle on a roadway for a nonagricultural purpose unless the person is at least 12 years of age and is accompanied by his or her parent or guardian or by a person at least 18 years of age who is designated by the parent or guardian.".
