The reference I mentioned to Jon Richards is on page 6, line 9. It deals with the oversight organization and mentions section 501(c) on the Internal Revenue Code. However, section 501(c) has 28 subunits. If you want to cover only the ones for which charitable contributions are tax deductible for the donor, you would probably want to limit it to 501(c)(3). These are the ones that have the restrictions on lobbying and prohibitions on political activity.

Jon had mentioned at the hearing that he has incorporated various 501(c)(3) corporations, but if he wants an associated corporation to do political activity, he'll do it as a 501(c)(4).

This is just a suggestion. But you may want to run it by some of the attorneys who testified at the hearing (Bobbie Petersen, Brynn McBride) before changing the bill.
