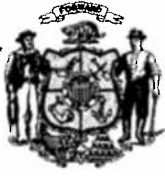

- 5 **3.** Page 7, line 22: after that line insert:
- 6 "(b) The department and the office of the commissioner of insurance shall
- 7 consider all of the following criteria before awarding a grant under sub. (2):
- 8 1. The organization's demonstrated expertise in the full array of health care
- 9 benefit programs.
- 10 2. The organization's demonstrated understanding of state statutes and rules
- 11 and federal statutes and regulations relating to private health insurance, including
- 12 eligibility, grievance procedures, and rights for independent review.
