To Whom It May Concern:

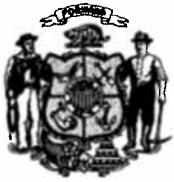
Could you please draft the following as amendments to AB 878? We apologize for the short notice, but we will be holding an executive session on this bill Wednesday morning and in order to comply with the 24 hour rule imposed by the Chairman we would need these completed by tomorrow at 10pm. Thanks for your assistance and understanding. Please feel free to contact me if I can be of any assistance.

- ✓ 1. **Under paragraph (e), lines 8-12 on page 4, insert the following language: "Must disclose which organizations has received funds dispensed by the oversight organization, how much and what the money was used for."** We want to require the "oversight organization" to have to provide information on who received money, how much and what was the money used for.
2. **Sunset the funding provided by OCI or Wisconsin to the oversight organization 2 years from July 2010 (the enactment of this legislation).**
3. **After 16 months insert' and every year thereafter the initial report"**. As it is currently written, the oversight organization only has to submit one report and nothing thereafter. To ensure accountability, we would like them to be required to submit a report every year thereafter the initial report 16 months after the effective date.
4. **Change the definition of Health care benefits on line 12 page 3 to say: government health care services, coverage of expenses for government health care services or both.** The point is having these groups provide services as it relates to government programs and services (example Medicaid) and not private health insurance. We don't want these groups providing services or information on private sector insurance.
5. **On page 7 line 4 after shall insert "prior to the receiving of funds"**. The intent would be to ensure that they have the capital required prior to receiving money from the oversight organization.
6. **Provide OCI or DHS with the authority to with hold funding to the oversight organization.**
