Rep. Sinicki has requested an amendment to Assembly Bill 885. Below are the changes that should all be included in one amendment:

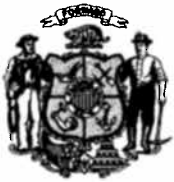
- 1) page 5, ll. 8: change "may" to "shall"
- 2) page 6, ll. 2 - 4: remove part of that sentence beginning at "without" and ending with "emergency".
- 3) make the following changes to Section 4:

"(4) OTHER LIVING WAGE INCREASES NOT PRECLUDED. The biennial living wage revision procedure specified in subs. (1) to (3) does not preclude the department from convening the minimum wage council at other times during the biennium ~~promulgating rules to increase the living wage at other times~~ if, upon investigation, the department finds that there is reasonable cause to believe that the wages paid to any employee are not a living wage. ~~If the department makes that finding, the department shall convene~~ The wage council thus convened shall study the need for an increase in the living wage as provided in sub. (1) and report its findings and recommendations as provided in sub. (2)."

The Assembly Committee on Labor is execing on this bill next Wednesday, so she needs the amendment for the exec. Let me know if you have any questions. Thanks!

p. 5, ll. 24: "...using the procedures under s. 227.24,".

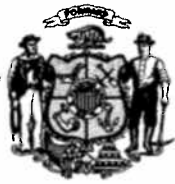
