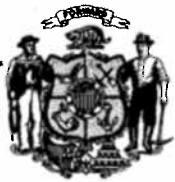

4 **3.** Page 4, line 5: delete “day” and substitute “day child”.

5 **4.** Page 4, line 6: delete “day” and substitute “day child”.

6 **5.** Page 4, line 7: delete “day” and substitute “day child”.

7 **6.** Page 4, line 17: after that line insert:

8 “**SECTION 4m.** 48.685[^] (5) (br) 3g. of the statutes is created to read:

9 48.685 (5) (br) 3g. An offense involving fraudulent activity as a recipient of a
10 child care subsidy under s. 49.155.”.

11 **7.** Page 4, line 21: delete “day care center or day” and substitute “day child care
12 center or day child”.

1 **8.** Page 5, line 5: delete "A" and substitute "~~A~~ Except for purposes of permitting
2 a person to be a nonclient resident of a child care center or child care provider, a".

3 **9.** Page 5, line 13: delete "An" and substitute "~~An~~ Except for purposes of
4 permitting a person to be a nonclient resident of a child care center or child care
5 provider, an".
