#2. to remove the provision that allows anyone to be placed on the permanent absentee ballot list for any reason. (p 44, line 19: Delete "succeeding" and lines 19-24 from "until the" through "application" along with any additional language that affects this provision.

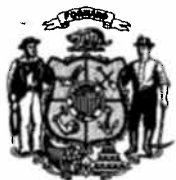

... draft an amendment to the proposed election bill that cuts off absentee voting on the Friday before elections at 5 p.m. This is absolutely necessary to be able to have a few days to get new registrations in the SVRS system, record the absentee ballots, get them filed and in order for election day, and prepare the necessary lists that must be delivered to the polls by 7 a.m. on election day.

...an amendment taking out the provision allowing anyone to be placed on the permanent absentee ballot list is also very important.
