Assumptions Used in Arriving at Fiscal Estimate

Under s. 175.35, generally a licensed firearms dealer may not transfer a handgun to a purchaser unless the purchaser has: 1) provided photo identification to the dealer; 2) completed a background information form; 3) passed a firearms restrictions record search conducted by the Department of Justice; and 4) forty-eight hours have elapsed from the time DOJ received the background information. The Federal Bureau of Investigation is responsible for conducting firearms restrictions record searches on long guns sold in Wisconsin.

DOJ operates the Handgun Hotline to receive telephone calls and background information forms from licensed firearms dealers between 9:00 a.m. and 9:00 p.m. on weekdays and 9:00 a.m. and 5:00 p.m. on weekends. The information provided by the dealers enables DOJ to perform the required background checks on handgun purchases. If an initial telephone review or a subsequent follow-up review discloses a disqualification that would bar handgun ownership, the purchase request is denied. The Handgun Hotline received 57,000 calls from dealers in 2009 and is staffed by six operators, one supervisor, and one clerical position.

2009 Assembly Bill 914 creates s. 175.33, relating to transfers of firearms. Under proposed s. 175.33, no person may sell or transfer ownership of a firearm, or purchase or obtain ownership of a firearm, unless: a) the seller or transferor is a firearms dealer; b) the sale or transfer of ownership of the firearm is to a law enforcement or armed services agency, between dealers or a wholesaler and a dealer, or involves an antique firearm; c) the transferor is transferring ownership of the firearm on a temporary basis or to a family member as a gift; or d) the seller or transferor makes the sale or transfer to or through a firearms dealer.

Regarding sales and transfers of firearms made through a firearms dealer under proposed s. 175.33, AB 914: 1) expands the current photo identification, firearms restrictions record search, and 48-hour time period conditions under s. 175.35 to apply to handgun sales and transfers between private parties; and 2) requires the transferee of a long gun to provide photo identification to the firearms dealer, and requires the firearms dealer to provide his or her name, contact information, and information that identifies the long gun to DOJ, when a long gun is sold or transferred between private parties.

DOJ estimates that these two changes will result in approximately a 50% increase in the number of handgun sales or transfers processed annually by the Handgun Hotline, and approximately 200,000 long gun sales or transfers reported annually to DOJ. To comply with the handgun provisions of AB 914, DOJ anticipates needing significant additional resources for the Handgun Hotline. To comply with the long gun provisions of AB 914, DOJ anticipates developing, providing, and maintaining an Internet application allowing gun dealers to enter required information. Based on these estimates, DOJ will need the following resources to meet its new responsibilities under AB 914:

Under s. 175.35 (2i), DOJ shall charge a firearms dealer a \$13 fee for each firearms restrictions record search that a firearms dealer requests. Under the provisions of AB 914, the \$13 fee would apply to sales and transfers of handguns between private parties through a firearms dealer. As a result, based on 25,000 new record searches per year, AB 914 would generate an additional \$325,000 PR annually for the Handgun Purchaser Record Check appropriation.

Long-Range Fiscal Implications
