Whereas, throughout its 100-year history, *The Progressive* has stayed true to the principles of Fighting Bob La Follette, including peace, civil rights, civil liberties, the environment, an independent media, the restraint of corporate power, and the expansion of citizen power; and

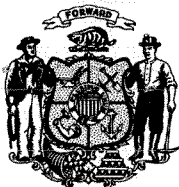
Whereas, *The Progressive* magazine, always based in Madison, has brought distinction to the state of Wisconsin by joining the national debate on the crucial issues of our day, with civility and intelligence;

Whereas the University of Wisconsin Press is publishing *The Progressive's* anthology this spring, *Democracy in Print: The Best of The Progressive, 1909-2009*; and
