

8	Wisconsin, where he was on the track and football teams, and he enlisted in the
9	United States Army a week after his high school graduation in June 2006; and
10	Whereas, Sergeant Christofferson was very proud to represent his country and
11	to serve in the United States Army; and
12	Whereas, Sergeant Christofferson was in his first tour of duty in Iraq, and he
13	received four medals including the Bronze Star Medal and the Purple Heart along
14	with a posthumous promotion to sergeant; and

Whereas, Steve is remembered as someone who was always smiling and fiercely devoted to those whom he loved, and his family and friends will remember him as a kind, thoughtful, and caring older brother and person; and

Whereas, Steve felt a deep affection for his country and the ideals it holds dear, and he served the United States and its citizens with determination and respect and was the example of duty, selflessness, and honor; and

Whereas, Steve will be sorely missed by all of those who knew him and by those whose lives he touched; now, therefore, be it
