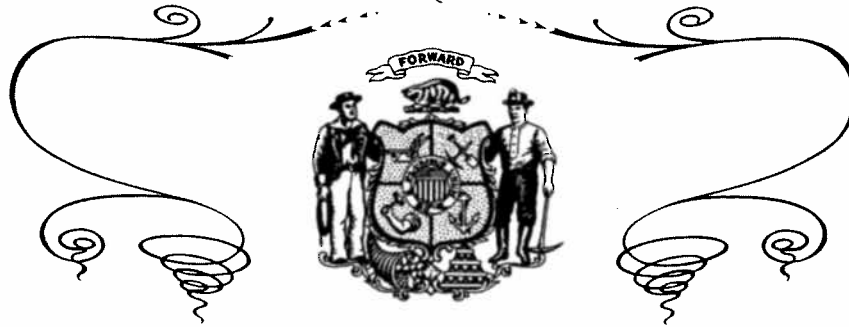

Whereas, the University of Wisconsin–La Crosse was founded in 1909 as the La Crosse State Normal School and established as a teacher preparatory institution with an original student body of 150 students; and

Whereas, the university's name was changed through the years before taking on its present name, the University of Wisconsin–La Crosse, when it merged with the University of Wisconsin System in 1971 as one of 13 four-year public universities in the University of Wisconsin System; and

Whereas, today, the University of Wisconsin–La Crosse enrolls nearly 10,000 students annually and offers 85 undergraduate programs in 30 disciplines and 21 graduate programs; and

Whereas, the University of Wisconsin–La Crosse has been consistently recognized and ranked nationally as one of the finest public comprehensive universities in the country; and
