1 **Relating to:** commending past and present members of the Friends of the Wisconsin  
2 Historical Society on its 60th anniversary.

3 Whereas, in 1950, an enthusiastic and dynamic woman, Ruth DeYoung Kohler,  
4 had a strong belief in historic preservation and felt the need to instill interest in the  
5 cultural heritage of Wisconsin; and

6 Whereas, Ruth DeYoung Kohler organized the Woman's Auxiliary of the State  
7 Historical Society of Wisconsin; and

8 Whereas, the Woman's Auxiliary eventually became known under its current  
9 name, the Friends of the Wisconsin Historical Society; and

10 Whereas, for the past 60 years, this organization of dedicated volunteers has  
11 been a valued partner of the Wisconsin Historical Society in the preservation,  
12 advancement, and dissemination of information relevant to Wisconsin's proud  
13 history; and

14 Whereas, the men and women of this independent volunteer organization have  
15 generously supplemented the activities of the Wisconsin Historical Society at a

1 significant cost savings to Wisconsin taxpayers and have enhanced the lives of  
2 residents throughout the state; now, therefore, be it

3 **Resolved by the senate, the assembly concurring, That** the members of the  
4 legislature of the state of Wisconsin commend past and present members of the  
5 Friends of the Wisconsin Historical Society on its 60th anniversary, and also  
6 commend that organization for its commitment to service on behalf of the people of
