

WHEREAS, Milwaukee Lutheran High School's Class of 2009 graduated on Saturday, May 30; and

WHEREAS, the aforementioned Class includes three graduates who have been accepted to the service academies for the education and training of commissioned officers of the United States Military, to wit: Nikko Ruud, accepted to the U.S. Air Force Academy in Colorado Springs, Colorado; Jonathan Kappel, accepted to the U.S. Naval Academy at Annapolis, Maryland; and Richard J. Wycklendt III, accepted to the U.S. Military Academy at West Point in New York; and

WHEREAS, these Academies are highly selective institutions, generally requiring applicants to be nominated by a Senator, Congressperson, or the Vice President of the United States, accepting only a small fraction of those who apply, and requiring successful applicants to demonstrate academic achievement, physical fitness, and good moral character; and

WHEREAS, the presence of two future Cadets and one future Midshipman in one graduating class is very rare and honors both the accepted students and Milwaukee Lutheran High School; and
