Some possible ways to have assembly take up bills:

1. Offer an assembly resolution that directs the Committee on Rules to offer a resolution making certain bills a special order of business on a specified date at a certain time. It would probably need to be targeted to a time when the assembly is already in a floor period.
2. Offer an assembly resolution that directs the Assembly Committee on Organization to call an extraordinary session to consider certain bills.
3. Offer a joint resolution calling for an extraordinary session to consider certain bills.
4. Offer motions to withdraw bills from committee and take up immediately.
