

- **SECTION 1.** Assembly rule 21 (1) is amended to read:
- Assembly Rule 21 (1) Any resolution to reprimand, censure, or expel an officer or member of the assembly shall be referred to a special committee on ethics and standards of conduct, convened for the purpose of holding one or more public hearings on the resolution and submitting the committee's recommendation to the assembly, only if at least 15 members of the assembly author the resolution. The

- special committee shall consist of 3 members of the majority party and 3 members of the minority party, appointed as are the members of standing committees.
