OTHER TAXATION

This bill adopts the substantive provisions of the Main Street Equity Act for purposes of administering and collecting state, county, and stadium district sales and use taxes. The act is intended to modernize sales and use tax administration for the states that adopt the act and to encourage out-of-state retailers to collect the state, county, and stadium district sales and use taxes voluntarily. Under current federal law, generally, an out-of-state retailer who sells tangible personal property or services to customers in this state is not required to collect the sales tax or use tax imposed on such sales, if the retailer has no physical presence in this state. See *Quill v. North Dakota*, 504 U.S. 298; 112 S. Ct. 1904 (1992).

This bill will be referred to the Joint Survey Committee on Tax Exemptions for a detailed analysis, which will be printed as an appendix to this bill.

For further information see the *state and local* fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

10 entertainment programs, and live events, but does not include video greeting cards
11 or video or electronic games.

14 personal property, or items, property, or works under s. 77.52 (1) (b), (c), or (d), or
15 taxable services” includes distributing, selecting recipients, determining mailing
16 schedules, or otherwise directing the distribution, dissemination, or disposal of
17 tangible personal property, or items, property, or works under s. 77.52 (1) (b), (c), or
18 (d), or taxable services, regardless of whether the purchaser of such property, items,
19 works, or services owns or physically possesses, in this state, the property, items,
20 works, or services.

21 **SECTION 127.** 77.51 (24) of the statutes is created to read:

22 77.51 (24) “Value-added nonvoice data service” means a service in which
23 computer processing applications are used to act on the form, content, code, or
24 protocol of the data provided by the service and are used primarily for a purpose other
25 than for transmitting, conveying, or routing data.
