

Please draft the following as separate amendments to SB 62. Please call if you have any questions.

JK Page 376 - Require the joint committee on finance to hold a public hearing on the proposed expenditure and issue a report containing a determination that all projects for which the funds are expended in the bill are an appropriate use of public funds..

JK Page 376 - Require the joint committee on finance to hold a public hearing on the proposed expenditure and issue a report containing a determination of the amount, if any, which the proposed expenditures contained in the bill will increase the state's structural deficit.

JK Page 376 - Require the joint committee on finance to hold a public hearing on the proposed expenditure and issue a report containing a determination that proper safeguards are contained in the bill to prevent any appropriated funds in the bill from being paid to an individual who or entity that has outstanding obligations to the state.

JK Page 376 - Require the joint committee on finance to hold a public hearing on the proposed expenditure and issue a report containing an estimate of the number of private sector jobs and public sector jobs that will be created by the projects for which the funds are expended.

JK Page 375-376 - Modify legislative oversight language to require oversight on all projects that are wholly or partially funded by federal stimulus dollars.

JK Page 377, line 18: Change "may" to "shall" in the provision requiring the first \$300M in fed stimulus to be spent on the enumerated projects.

JK Page 380, line 1: Insert "48. The USH 51 project from the intersection of USH 51 and Reardon Road to just north of the intersection of USH 51 and CTH V/Grinde Road in the village of DeForest."

JK Page 103, lines 6 & 7: After the word "2008", insert a period and delete remainder of that line and all of line 7 to remove the sunset from the DMTC.
