Please draft the following as separate amendments to SB 62. Please call if you have any questions.

Page 376 - Require the joint committee on finance to hold a public hearing on the proposed expenditure and issue a report containing a determination that all projects for which the funds are expended in the bill are an appropriate use of public funds..

Page 376 - Require the joint committee on finance to hold a public hearing on the proposed expenditure and issue a report containing a determination of the amount, if any, which the proposed expenditures contained in the bill will increase the state's structural deficit.

Page 376 - Require the joint committee on finance to hold a public hearing on the proposed expenditure and issue a report containing a determination that proper safeguards are contained in the bill to prevent any appropriated funds in the bill from being paid to an individual who or entity that has outstanding obligations to the state.

Page 376 - Require the joint committee on finance to hold a public hearing on the proposed expenditure and issue a report containing an estimate of the number of private sector jobs and public sector jobs that will be created by the projects for which the funds are expended.

Page 375-376 - Modify legislative oversight language to require oversight on all projects that are wholly or partially funded by federal stimulus dollars.

Page 377, line 18: Change "may" to "shall" in the provision requiring the first \$300M in fed stimulus to be spent on the enumerated projects.

Page 380, line 1: Insert "48. The USH 51 project from the intersection of USH 51 and Reardon Road to just north of the intersection of USH 51 and CTH V/Grinde Road in the village of DeForest.".

Page 103, lines 6 & 7: After the word "2008", insert a period and delete remainder of that line and all of line 7 to remove the sunset from the DMTC.

# ASSEMBLY AMENDMENT, TO 2009 SENATE BILL 62

At the locations indicated, amend the bill as follows:

**1.** Page 376, line 10: after that line insert:

"(ch) *Public hearing and issuance of report*. Before approving the expenditure of federal economic stimulus funds under a plan or plans submitted by the governor, the joint committee on finance shall hold a public hearing and issue a report that contains a determination by the committee that proper safeguards are contained in the plan or plans to prevent any appropriated funds from being paid to an individual who or entity that has outstanding obligations to the state."
