\*\*\*\*NOTE: This is drafted to page and line numbers ins LRB1152/P11.  
\*\*\*\*NOTE: The amendment deletes the transfer from the hospital assesment fund to the MA trust fund. It also deletes the \$3 million annual supplement to UW hospitals and clinics because the supplemental payment is made from the MA trust fund (presumably from the \$\$ that are transferred from the hospital assesment fund). It also deletes the appropriation of admin dollars for DHS (which comes from the MA trust fund and is equal to 0.5% of the amount transferred from the hospital assesment fund to the MA trust fund.  
\*\*\*\*NOTE: It reduces the amount in the schedule for 20.435 (4) (xc) by \$79, 604,800 (the amount of the transfer from the hospital assesment fund to the MA trust fund). It also deletes the fiscal changes for 20.435 (4) (w) (MA trust fund) and 20.435 (4) (b) (MA GPR appropriation)
