TO 2009 SENATE BILL 62



1 At the locations indicated, amend the bill as follows:

1. Page 35, line 17: after that line insert:

"Section 67d. 49.95 (4r) of the statutes is created to read:

49.95 (4r) Any person who commits a violation under the swipe card system established for the child care susidy program under s. 49.155 may be fined not more than \$25,000 or imprisoned for not more than 9 months or both.".
