

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 19, line 1: delete "From" and substitute "~~From~~ Subject to s. 50.38 (10),  
3 from".

4 **2.** Page 27, line 24: after "under s. 50.38" insert ", subject to s. 50.38 (10),".

5 **3.** Page 28, line 10: after "sub. (3) (e)" insert "and subject to s. 50.38 (10)".

6 **4.** Page 28, line 21: after "sub. (3) (e)" insert "and subject to s. 50.38 (10)".

7 **5.** Page 30, line 18: after "sub. (3) (e)" insert "and subject to s. 50.38 (10)".

8 **6.** Page 31, line 1: after "sub. (3) (e)" insert "and subject to s. 50.38 (10)".

9 **7.** Page 32, line 18: delete "The" and substitute "Subject to s. 50.38 (10), the".

10 **8.** Page 39, line 16: after that line insert:

11 "(10) The department shall ensure that none of the following moneys are  
12 disbursed to a hospital, as defined in s. 50.33 (2), or clinic that performs or to a

1 hospital or clinic affiliated with a health care provider, as defined in s. 146.81 (1), that  
2 performs abortions, as defined in s. 253.10 (2) (a), in the 2nd or 3rd trimester of  
3 pregnancy or both; <sup>except as provided in s. 20.927 (2)</sup>

4 (a) Moneys that are collected under sub. (2) and expended under s. 49.45 (3) (e)  
5 11., (5m), (5r), (6y) (ap) or (ar), or (59) (a).

6 (b) Moneys that are collected under sub. (2) and refunded under sub. (6).

7 (c) Moneys that are collected under sub. (2), transferred under sub. (8), and  
8 expended from the Medical Assistance trust fund.”.
