Annexations for Kaukauna

Motion:

Move to specify that the City of Kaukauna may annex territory outside of Outagamie County without the following: (a) a resolution adopted by the town board from the town in which territory would be annexed from; and (b) a resolution passed by the county board in which the territory is located.

Note:

Under current law, a city or village may seek to annex unincorporated territory. No territory may be annexed by a city or village if no part of the city or village is located in the same county as the territory that is subject to the proposed annexation unless all of the following occur: (a) the town board adopts a resolution approving the proposed annexation; and (b) the county board of the county in which the territory is located adopts a resolution approving the proposed annexation. This motion would allow the City of Kaukauna to annex territory that is outside of Outagamie County without resolutions from the town and county boards of the affected territory.


