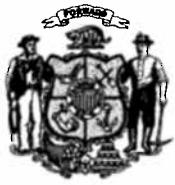

9 "f. A person who is serving a sentence for a drug-related crime, as defined in
10 s. 939.22 (11m)."

“SECTION 3339m. 939.22 (11m) of the statutes is created to read:

939.22 (11m) “Drug^{or} related crime” means a violation of s. 961. 41 (1) (b), (h) 2.,
(i), (j), (1m) (b), (h) 2., (i), (2) (b), (d), (3g) (am), (c), (d), (e), (h)^{or}, (g)^{or}, (3j)^{or}, 961.42, 961.43,
961.453 (1) (b) 1. or 2., 961.573 (3) (b) 1., 961.574 (3), 961.65, or 961.67 (4) (a).”

5. Page 1709, line 18: after “justice.” insert “This subsection does not apply to
a person who is sentenced for a drug^{or} related crime, as defined in s. 939.22 (11m).”.

6. Page 1712, line 7: after “(1).” insert “This section does not apply to a person
