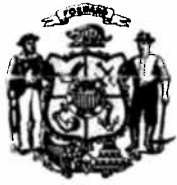

TO 2009 ASSEMBLY BILL 75

1 At the locations indicated, amend the substitute amendment as follows:

2 1. Page 1441, line 4: after that line insert:

3 "f. A person who is serving a sentence for a violation of s. 940.31 (1)". 940.302

4 2. Page 1709, line 18: after "justice." insert "This subsection does not apply if  
5 the court sentences a person for a violation of s. 940.31 (1)". 940.302

6 3. Page 1712, line 7: after "(1)." insert "This section does not apply if the court  
7 sentences a person for a violation of s. 940.31 (1)". 940.302
