Please draft separate assembly amendments to (ASA 1 to) AB 75 for the following:

1. Delete language from motion 744 item 16, collective bargaining for daycare providers. Goal is to retain current law.
2. Delete language from motion 744 item 3, W-2 program changes that eliminates the Learnfare program. Alternative 1 in LFB paper 227. Goal is to retain current law on Learnfare.
3. MA Funding Reductions (paper 417. page 351 in Fiscal Bureau Summary). Require DHS to submit plans to the Joint Finance Committee for active review before making any rate reductions. *RLR*
4. Freeze enrollment on BadgerCare for childless adults until next biennium.
5. Eliminate the provision on One- and Two-Bed Adult homes (LFB Summary page 391) *RLR*
- 6. A provision of 2009 Act 2 eliminated the statutory requirement that a report be filed if the MA trust fund goes negative. Please draft language to restore that requirement. *TSD*

5 organization, the joint committee on finance, and ^{the} appropriate standing committee,
6 as determined by the presiding officer of each house, if the amounts appropriated for
7 the state share of medical assistance are insufficient to provide the state share of
8 medical assistance."
