



Improve the Dane County Regional Transportation Authority with the following four provisions, in the order of importance:

- 1. Specify that the RTA Board would have to hold a binding referendum of the electors of the RTA's jurisdictional area on the question of whether the RTA board should impose the 0.5% sales and use tax.**
- 2. Expand the RTA board to include one town member, who must reside within the jurisdiction of the RTA, to be appointed by the Dane County Towns Association.**
- 3. Clarify that the one village member, who must reside within the jurisdiction of the RTA and be appointed by the Dane County Cities and Villages Association, actually be a rotating (every two years) position by a representative of either a village, or a city within the jurisdiction of the RTA that does not have an automatic position on the board of directors.**
- 4. Allow the RTA to fund road and highway projects with the generated sales tax revenue as they relate to regional transportation needs.**

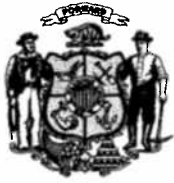
