5 20.540 (1) ✓ (a) of the statutes, as affected by the acts of 2009, the dollar amount is  
6 decreased by \$51,000 for the first fiscal year of the fiscal biennium in which this  
7 subsection ✓ takes effect and is decreased by \$67,800 for the second fiscal year of the  
8 fiscal biennium in which this subsection ✓ takes effect to decrease the authorized FTE  
9 positions for the office by 1.0 GPR position for constituent services and external  
10 relations.”.
