3 price of motor vehicle fuel in order to recover the amount of the assessment based on
4 fuel that is sold to Wisconsin retailers that are located within 20 miles of the border
5 of a state where the retail price of motor vehicle fuel sold within 20 miles of
6 Wisconsin's border is lower". that is
