

3. delete JFC's Motion #755 (2), relating to Construction Contractors: Require, effective 1/1/2010, the following: (a) 1% withholding on payments to independent contractors and single member limited liability companies (LLCs) providing construction services when a 1099 tax form is filed; (b) establish a fine of \$25,000 under state laws governing unemployment insurance, worker's compensation, equal rights, state income sales, excise, and inheritance taxes, and public safety for willful misclassification of workers; (c) require construction contractors to register with the Dept of Commerce and provide Commerce with authority to levy administrative forfeiture for failure to register; (d) exempt homeowners, tenants, and state and local governmental units from these provisions; and (e) require Commerce to promulgate administrative rules to administer registration of contractors under (c); Commerce, #8, page 274, and Revenue, #17, page 759
