A retailer who files, or is required to file, an application under s. 77.52 (7) or who registers, or who is required to register, under s. 77.53 (9) or (9m) shall collect, report, and remit to the department the taxes imposed under this subchapter for all counties and special districts that have an ordinance or resolution imposing the taxes under this subchapter.".
