4 (a) In this subsection, “project” means the highway improvement project in the
5 city of Kiel that the department of transportation has identified as project number

7 (b) If the department of transportation has not awarded, prior to the effective
8 date of this paragraph, a contract for the construction of the project, the department
9 of transportation may not award any contract for the project until after June 30,
10 2012. ✓

11 (c) If the department of transportation has awarded, prior to the effective date
12 of this paragraph, a contract for the construction of the project, the department of

1 transportation shall require that the contractor halt construction of the project until
2 after June 30, 2012." ✓
