

**ASSEMBLY AMENDMENT ,  
TO 2009 SENATE BILL 4**

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 8, line 23: after that line insert:

3 (b) "Employer" means a person that employs travelling sales crews to sell  
4 goods or services to consumers from house to house, on any street, or in any other  
5 place that is open to the public. "Employer" includes a nonprofit organization or  
6 association described in section 501 (c) (4) of the Internal Revenue Code or a political  
7 organization described in section 527 of the Internal Revenue Code that employs  
8 travelling sales crews to solicit contributions from house to house, on any street, or  
9 in any other place that is open to the public."

10 **2.** Page 9, line 2: after "salespersons" insert "or solicitors".

11 **3.** Page 9, line 4: after "consumers" insert "or of soliciting contributions".

12 **4.** Page 9, line 10: after "consumers" insert "or the solicitation of  
13 contributions".
