## 2009 ASSEMBLY BILL 103

1	AN ACT to amend 447.03 (1) (intro.), 447.03 (2) (intro.), 447.055 (1) (a) and
2	447.056 (1) (intro.); and <i>to create</i> 447.02 (3) of the statutes; relating to:
3	authorizing temporary permits to practice dentistry or dental hygiene without
4	compensation.

# *The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

5 SECTION 1. 447.02 (3) of the statutes is created to read:
6 447.02 (3) (a) The examining board may issue a permit authorizing the practice
7 in this state, without compensation, of dentistry or dental hygiene to an applicant
8 who is licensed to practice dentistry or dental hygiene in another state, if all of the
9 following apply:
10 1. The examining board determines that the applicant's services will improve

11 the welfare of Wisconsin residents.

1	2. The examining board determines that the applicant is qualified and satisfies
2	the criteria specified under s. 447.04 (1) (b) 1. to 3., except that the examining board
3	may not require the applicant to pass an examination of state statutes and rules

5	(b) A permit under this subsection shall authorize the practice of dentistry or
6	dental hygiene in a specified area of the state for a period of time not more than 10
7	days in a year and may be renewed by the examining board. The examining board
8	may not require an applicant to pay a fee for the issuance or renewal of a permit
9	under this subsection.
10	<b>SECTION 2.</b> 447.03 (1) (intro.) of the statutes is amended to read:
11	447.03 (1) DENTISTS. (intro.) Except as provided under sub. (3) and s. ss.

3 **SECTION 5.** 447.056 (1) (intro.) of the statutes is amended to read: 4 447.056 (1) (intro.) Except as provided in subs. (2) to (4), a person is not eligible 5 for renewal of a license to practice dentistry, other than a permit issued under s. 6 447.02 (3), unless the person has taught, attended, or otherwise completed, during 7 the 2-year period immediately preceding the renewal date specified under s. 440.08 8 (2) (a), 30 credit hours of continuing education related to the practice of dentistry or 9 the practice of medicine, including not less than 25 credit hours of instruction in 10 clinical dentistry or clinical medicine.
