

TO ASSEMBLY SUBSTITUTE AMENDMENT 1,  
TO 2009 ASSEMBLY BILL 16**

~~At the locations indicated, amend the substitute amendment as follows:~~

**1.** Page 4, line 18: delete "par. (c)" and substitute "pars. (c) and (cm)".

**2.** Page 6, line 2: after that line insert:

"(cm) ✓ If a child who, as a dependent of his or her parent, first obtains coverage under a group disability insurance policy or a self-insured health plan after the effective date of this paragraph ✓ ... [LRB inserts date], receives a hearing aid or cochlear implant within the first year after the effective date of the coverage and then discontinues the coverage before one year from the date on which the coverage was effective, or if a child who, as a dependent of his or her parent, first obtains coverage under an individual disability insurance policy ✓ after the effective date of this paragraph ✓ ... [LRB inserts date], receives a hearing aid ✓ within the first year after the effective date of the coverage and then discontinues the coverage before one year

1 from the date on which the coverage was effective, the individual or group disability  
2 insurance policy or self-insured health plan shall provide the coverage as required  
3 under this subsection but may require that benefits paid for the cost of the hearing  
4 aid or cochlear implant be reimbursed if the insurer demonstrates to the satisfaction  
5 of the commissioner that coverage under the individual or group disability insurance  
6 policy or self-insured health plan was obtained primarily for the coverage required  
7 under this subsection.” ✓
