2009 SENATE BILL 232

June 5, 2009 - Introduced by Senators MILLER and DECKER, cosponsored by Representatives POCAN and SHERIDAN. Referred to Joint Committee on Finance.

1 **AN ACT relating to:** the payment of state school aid in June 2009.

Analysis by the Legislative Reference Bureau

Current law lapses \$291,000,000 in the 2008-09 fiscal year from the state school aid appropriation to the general fund and directs the Department of Public Instruction (DPI) to use \$291,000,000 in federal funds received under the American Recovery and Reinvestment Act of 2009 (ARRA) to make payments to school districts in June 2009.

This bill lapses an additional \$261,278,000 in school aid to the general fund in the 2008-09 fiscal year and directs DPI to use an additional \$261,278,000 in federal funds received under ARRA to make payments to school districts in June 2009.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

2 **SECTION 1. Nonstatutory provisions.**

3 (1) STATE SCHOOL AID; JUNE 2009. In the second fiscal year of the fiscal biennium
4 in which this subsection takes effect, in addition to the lapse required in 2009
5 Wisconsin Act 11, section 9139 (1f), there is lapsed to the general fund \$261,278,000

2 Notwithstanding sections 121.07 and 121.08 of the statutes, in addition to the
3 amount specified in 2009 Wisconsin Act 11, section 9139 (1f), the department of

5 20.255 (2) (ac) of the statutes and \$261,278,000 of the amount appropriated in the
6 second fiscal year of the fiscal biennium in which this subsection takes effect under
7 section 20.255 (2) (p) of the statutes, as created by 2009 Wisconsin Act 11, to make
8 payments to school districts in June 2009 under section 121.15 (1) and (1g) of the
9 statutes.
