 - (b) There is created in the public service commission a wind siting council that consists of the following members appointed by the public service commission for 3–year terms:
 - 1. Two members representing wind energy system developers.
- 2. One member representing towns and one member representing counties.
- 3. Two members representing the energy industry.

- 5. Two members representing realtors.
- 6. Two members who are landowners living adjacent to or in the vicinity of a wind energy system and who have not received compensation by or on behalf of owners, operator, or developers of wind energy systems.
 - 7. Two public members.
- 8. One member who is a University of Wisconsin System faculty member with expertise regarding the health impacts of wind energy systems.".
 - **2.** Page 3, line 1: delete "Section 1" and substitute "Section 1s".
- 9 **3.** Page 10, line 7: delete "WIND SITING RULES" and substitute "WIND ENERGY systems".
 - **4.** Page 10, line 11: after "shall" insert ", with the advice of the wind siting council,".
 - **5.** Page 10, line 20: after "shall" insert ", with the advice of the wind siting council,".
 - **6.** Page 11, line 6: after that line insert:
 - "(d) The wind siting council shall survey the peer–reviewed scientific research regarding the health impacts of wind energy systems and study state and national regulatory developments regarding the siting of wind energy systems. No later than the first day of the 60th month beginning after the effective date of this paragraph [LRB inserts date], and every 5 years thereafter, the wind siting council shall submit a report to the chief clerk of each house of the legislature, for distribution to the appropriate standing committees under s. 13.172 (3), describing the research and regulatory developments and including any recommendations of the council for legislation that is based on the research and regulatory developments.".
