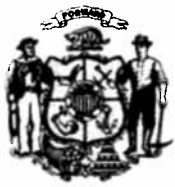

- 5 or a participant in the Wisconsin Works Program, including a person receiving a
- 6 child care subsidy under that program, to be reported to an immediate supervisor,
- 7 to the sheriff, and to the departmental fraud investigation unit; ineligibility for a
- 8 child care subsidy under Wisconsin Shares for a violation under the program; use of
- 9 funds recovered for detecting fraud under Wisconsin Shares; making an
- 10 appropriation; and providing a penalty".
- 11 **2.** Page 6, line 19: delete the material beginning with that line and ending with

5 the employee shall immediately report the facts and circumstances contributing to
6 that suspicion to the employee’s immediate supervisor.

8 immediately evaluate the report to determine whether there is reason to suspect that
9 the fraudulent activity has occurred or is occurring. If the immediate supervisor
