

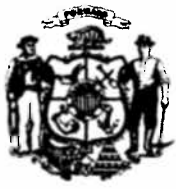

- 8 of children and families shall, no later than July 1, 2010, implement a program for
- 9 recording and monitoring attendance under the child care subsidy program under
- 10 section 49.155 of the statutes that does either of the following, whichever the
- 11 department determines would be more efficient and effective:
- 12 1. Uses a fingerprinting system instead of a swipe card system.
