5 49.133 (1m) (c) The person If a child care provider, caregiver specified in s.
6 48.685 (1) (ag) 1. a., or nonclient resident, as defined in s. 48.685 (1) (bm), of the child
7 care provider has been determined under s. 48.981 to have abused or neglected a
8 child, the department or county department under s. 46.215, 46.22, or 46.23 shall
9 refuse to pay the child care provider for any child care provided under s. 49.132, 1995
10 stats., or any other program beginning on the date of the determination." ✓

11 2. Page 22, line 7: after that line insert:

12 "3m. If a child care provider, caregiver specified in s. 48.685 (1) (ag) 1. a., or
13 nonclient resident, as defined in s. 48.685 (1) (bm), of the child care provider has been

1 determined under s. 48.981 to have abused or neglected a child, the department or
2 county department under s. 46.215, 46.22, or 46.23 shall refuse to pay the child care
3 provider for any child care provided under this section beginning on the date of the
4 determination.”.

5 **3.** Page 22, line 24: delete lines 24 and 25.
