senate amendment 1 to senate amendment 31
after "Shares;"^{inserted}

1 At the locations indicated, amend the bill as follows:

2 1. Page 2, line 2: after "provided" insert "increasing the amount of funding
3 to counties and tribal governing bodies for fraud prevention;"

4 2. Page 23, line 23: after that line insert: → after the material inserted
5 "SECTION 39t. Fiscal changes." by senate amendment 31

6 (1) FUNDING FOR FRAUD PREVENTION. In the schedule under section 20.005 (3) of
7 the statutes for the appropriation to the department of children and families under
8 section 20.437 (2) (dz) of the statutes, as affected by the acts of 2009, the dollar
9 amount is increased by \$1,250,000 for fiscal year 2009-10 and the dollar amount is
10 increased by \$1,250,000 for fiscal year 2010-11 to increase funding for counties,
11 excluding a county having a population of 500,000 or more, and for tribal governing
12 bodies for fraud detection and prevention under the Wisconsin Works program."
