ASSEMBLY AMENDMENT ,
TO 2009 ASSEMBLY BILL 266

1 At the locations indicated, amend the bill as follows:

2 1. Page 1, line 6: delete the material beginning with "layoff" and ending with
3 "penalty" on page 1, line 7 and substitute "layoff".

4 2. Page 2, line 1: delete that line and substitute:

5 "SECTION 1d. 106.11 of the statutes is amended to read:

6 **106.11 Workforce investment programs.** The department shall cooperate
7 with the federal government in carrying out the purposes of the federal Workforce
8 Investment Act of 1998, 29 USC 2801 to 2945. In administering the programs
9 authorized by that act the department shall, in cooperation with other state agencies
10 and with local workforce development boards established under 29 USC 2832,
11 establish a statewide workforce investment system to meet the employment,
12 training, and educational needs of persons in this state. If a local workforce
13 development board anticipates that there may be a business closing or mass layoff

1 under s. 109.07 in the area served by that board, the board may prepare a list of
 2 resources available in that area that provide career planning, job search, job skills
 3 training, and other support services for affected employees, as defined in s. 109.07
 4 (1) (a), including contact information for those resources, for distribution to those
 5 employees under s. 109.07 (1m) (a).

7 **3.** Page 3, line 7: delete "located." and substitute "located and, if available, the
 8 list of resources prepared under s. 106.11.".

9 **4.** Page 3, line 18: delete "(d)" and substitute "(c)".

10 **5.** Page 3, line 20: delete the material beginning with that line and ending with
 11 page 4, line 6.
