Under current law, rules of the road apply upon highways, with certain exceptions. Current law defines "highway" to include all public ways and thoroughfares and bridges on the same. "Highway" includes roads or driveways in parks and in state forests that are open to the public and roads or driveways that are on the grounds of public schools and under the jurisdiction of the county. However, a private road or driveway is not considered a highway.
