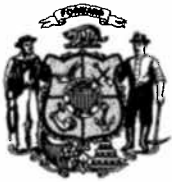

- 1) Page 3, line 1: per DPI's request, change the statutory reference in directing the department to apply for federal teen pregnancy prevention funds.

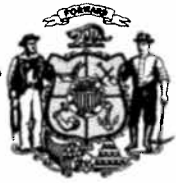
Replace statutory reference in section 1 with "115.29 (7) of the statutes is created to read:

- 2) Page 5, lines 8-11

- 3) Page 6, line 10-12
