SENATE AMENDMENT 5, TO 2009 ASSEMBLY BILL 458

January 28, 2010 - Offered by Senators Lazich and Grothman.

1 At the locations indicated, amend the engrossed bill as follows:

- 2 **1.** Page 4, line 20: delete "If" and substitute "Except as permitted in sub. (2p), if".
 - **2.** Page 6, line 13: after that line insert:
 - **SECTION 5v.** 118.019 (2p) of the statutes is created to read:
 - 118.019 **(2p)** Abstinence-only human growth and development. (a) In addition to the instructional program provided under sub. (2), a school board may offer courses in abstinence-only human growth and development. Courses offered under this subsection shall be made available to any pupil whose parent or guardian submits a written request that his or her child take instruction in abstinence-only human growth and development.
 - (b) A school board that elects to offer courses in abstinence—only human growth and development may establish policies to determine all of the following:

- 1. The subjects, identified under sub. (2), to be included in and excluded from the abstinence–only human growth and development curriculum.
- 2. Whether to offer an abstinence—only human growth and development course in any grade in any particular school year. Policies developed under this subdivision may include consideration of the level of interest in abstinence—only human growth and development courses among the parents and guardians of pupils enrolled in the school district.
- (c) A school board that elects to offer courses in abstinence—only human growth and development shall provide to the parent or guardian of each child who is enrolled in an abstinence—only human growth and development course a complete list of all subjects identified under sub. (2) that will not be covered in the course offered under this subsection.".
- **3.** Page 6, line 25: after "classroom." insert "<u>If a school board offers an abstinence</u>—only human growth and development curriculum as permitted under sub. (2p), the school board shall make the complete abstinence—only human growth and development curriculum and all instructional materials available for inspection by a parent or guardian upon his or her request at any time, including prior to their use in the classroom.".
- **4.** Page 7, line 16: after "development" insert "or abstinence—only human growth and development".
 - **5.** Page 7, line 16: after "under" insert "either".
- **6.** Page 7, line 17: after "(2)" insert "or (2p)".
 - **7.** Page 7, line 18: after that line insert:
 - "Section 9r. 118.019 (5) of the statutes is amended to read:

118.019 **(5)** Advisory committee. In any school district that offers a human growth and development curriculum, including an abstinence—only human growth and development curriculum, the school board shall appoint an advisory committee composed of parents, teachers, school administrators, pupils, health care professionals, members of the clergy, and other residents of the school district. The advisory committee shall develop the human growth and development curriculum and, if applicable, the abstinence—only human growth and development curriculum, and advise the school board on the design, review, and implementation of the advisory committee's human growth and development curriculum. The advisory committee shall review the curriculum at least every 3 years."
