Representative Richards requests that you draft an amendment to AB614 that incorporates the quality disclosure language from AB539.

The following language can be found on page 8, lines 24 and 25 of AB539:

b. Objective quality data that is related to the health outcome of the proposed course of treatment, if the health care provider has made public the data.

In the context of AB539 it appears that this language only applies to those practices listed in point 4. Representative Richards would like this language added to his bill but for it to apply to the disclosures under (4) on page 5 of AB614. It is his intent to require a quality disclosure for all providers who are required to disclose cost data for the top 25 conditions (75 as amended). Does inserting the proposed language under (4) accomplish this goal?
