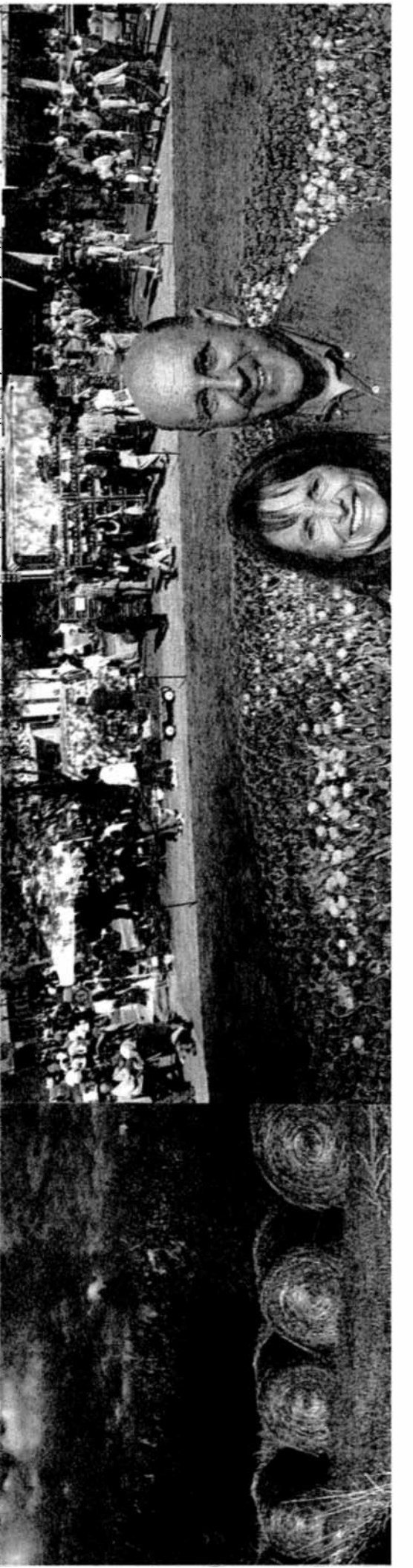

2 1. Page 1, line 4: delete "~~I 94 north of Tomah I 39/USH 51 in Waushara~~" and
3 substitute "I 94 north of Tomah to CTH "Z" in the town of Strongs Prairie in Adams
4 County and from STH 13 north of the village of Friendship in Adams".

5 2. Page 2, line 6: delete the material beginning with "~~I~~" and ending with
6 "Waushara" on line 7 and substitute "CTH "Z" to STH 13 in Adams".

7 3. Page 2, line 8: delete the material beginning with "~~I~~" and ending with
8 "Waushara" on line 9 and substitute "CTH "Z" to STH 13 in Adams".

9 4. Page 2, line 12: delete "I 94 north of Tomah to I 39/USH 51 in Waushara"
10 and substitute "CTH "Z" to STH 13 in Adams".
