- 1 AN ACT *to create* 70.11 (45) of the statutes; **relating to:** a property tax exemption
- 2 for snowmobile and all-terrain vehicle clubs.

#### Analysis by the Legislative Reference Bureau

This substitute amendment provides a property tax exemption for trail groomers owned by a snowmobile club or an all-terrain vehicle club that is a nonprofit organization.

# The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

- 3 **SECTION 1.** 70.11 (45) of the statutes is created to read:
- 4 70.11 (45) SNOWMOBILE AND ALL-TERRAIN VEHICLE CLUBS. Trail groomers owned
- 5 by a snowmobile club or an all-terrain vehicle club that is exempt from taxation
- 6 under section 501 (c) (3), (4), or (7) of the Internal Revenue Code.
- 7 Section 2. Initial applicability.

1 (1) This act first applies to the property tax assessments as of January 1, 2009.
