- 2 **1.** Page 1, line 6: after "pupils" insert "and granting rule-making authority".
- 3 **2.** Page 3, line 1: delete lines 1 to 12 and substitute:
- 4 "Section 1m. 115.001 (11) of the statutes is amended to read:
 - 115.001 (11) SCHOOL NURSE. "School nurse" means a registered nurse licensed under ch. 441 s. 441.06 or in a party state, as defined in s. 441.50 (2) (j), who is also certified by the department as being qualified to perform professional nursing services in a public school meets the qualifications for school nurses prescribed by the department by rule.".
 - **3.** Page 5, line 24: delete "sealed".
 - **4.** Page 8, line 13: delete lines 13 to 15 and substitute:
- "Section 16m. Effective dates. This act takes effect on the first day of the
 12th month beginning after publication, except as follows:

1 (1) The treatment of sections 115.001 (11) and 115.88 (1) and (1m) (am) and (b)
2 of the statutes takes effect on September 1, 2010.".
