- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 1, line 6: after “pupils” insert “and granting rule-making authority”.
- 3 **2.** Page 3, line 1: delete lines 1 to 12 and substitute:
- 4 **“SECTION 1m.** 115.001 (11) of the statutes is amended to read:
- 5 115.001 (11) SCHOOL NURSE. “School nurse” means a registered nurse licensed
- 6 under ~~ch. 441 s. 441.06~~ or in a party state, as defined in s. 441.50 (2) (j), who is also
- 7 ~~certified by the department as being qualified to perform professional nursing~~
- 8 ~~services in a public school~~ meets the qualifications for school nurses prescribed by
- 9 the department by rule.”.
- 10 **3.** Page 5, line 24: delete “sealed”.
- 11 **4.** Page 8, line 13: delete lines 13 to 15 and substitute:
- 12 **“SECTION 16m. Effective dates.** This act takes effect on the first day of the
- 13 12th month beginning after publication, except as follows:

1 (1) The treatment of sections 115.001 (11) and 115.88 (1) and (1m) (am) and (b)  
2 of the statutes takes effect on September 1, 2010.”
